- For the IB Diploma, a student must choose six subjects, one each from group 1 to 6. Three subjects must be chosen at Higher Level. Students who do not wish to take a subject from group 6 (the Arts) can choose an additional subject from group 3 or 4.
- The EE, TOK, and CAS are compulsory courses in the core of the programme. All students take a course on the Theory of Knowledge (TOK) and must fulfil the requirements of CAS (Creation, Action, Service) in order to obtain the IB Diploma.

- While we will try to meet the interests of every student, we cannot always guarantee a course. Subjects denoted with a star (*) will only be offered if enough students choose the course. Students must indicate a second preference in case their first choice is not offered.
- If you wish to pursue a career in a Science-Math field (eg. Engineering), you may select 2 science courses.
- If you wish to pursue a career in a Turkish-Math field (eg. Law, Business Management), you may select either the second or the third block.
- Whatever block you opt for, you need to select HL or SL for each course you choose.
- Math AA is offered in HL and SL, and the content of each level is different. You should research the requirements of the university you wish to apply to before you make a selection. We do not advise selecting Math HL if your grade average for this course is below 85.
- We do our best to offer courses that suit the interest of all of our students. However, some courses (eg. all of the 3 sciences) may If this is the case, you may be called for another interview to discuss the other options.
- Please remember that you will also be responsible for courses in the national curriculum. These courses will be conducted concurrently with IB Diploma Programme courses.
- Please review the subject choices carefully and discuss your options with your parents before you make your final decision.
- Do not hesitate to consult your DP coordinator if you have any questions.
